In view of the present circumstances arising due to COVID19 and possibility of low revenue receipts in the current financial year, it is proposed to put the execution of all infrastructure projects on hold till further decision is taken by the Board of Governors. Item No.3 To consider the payment of contingency Staff (Non essential services) during the period of lockdown.

During the period of lockdown from 23<sup>rd</sup> March 2020 onwards 47 number of temporary contingency employees (Safai Karmachari, Electricians, Plumber, Maintenance, Guest House, Gardeners, and Drivers reported to their duties according to roaster of Government Madhya Pradesh. Their salary will be disbursed as usual.

The 51 temporary employees such as Clerks, Peons working in various departments, institute office and hostels could not report to their duties due to national lockdown. The salary expenditure towards these 51 employees is Rs.4,90,211/- per month. It is proposed to release their salary for the lockdown period (As of now till 3<sup>rd</sup> May 2020).

Item No.4 To report about the Conduction of online classes during lockdown Period

Since the institute was closed on 16<sup>th</sup> March 2020, classes are being conducted through online mode via ZOOM, Video Conferencing MOODLE, NPTEL, SWAYAM and Video lectures prepared by the faculty members.
