Radhakrishnan on 11th December, 1964. On the occasion of Golden Jubilee Celebrations of the Institute, the president of India, Dr. Pratibha Devi Singh Patil graced the Golden Jubilee Celebrations of the Institute as Chief Guest on 30th June, 2008. A postal stamp on MITS was also released on this occasion.
